Terms and Conditions of Your Entry

1. Feature Film entries to the 2007 Home Brewed International Film Festivals must comply with the following conditions:
 - a) total film length, (including all titles and credits) must be greater than 60 minutes.
 - b) must have been made since 1 January 2004, and cannot be a previous finalist in Home Brewed;
 - c) all entries to be submitted on DVD or VHS cassette tape only, labeled with the name of the film and contact details in case the disc becomes separated from the entry form. Copies must be checked before sending – poor, unplayable or partial copies will not be considered and a refund of the entry fee will be at the discretion of the festivals. Films selected for screening will be required to provide DVD masters;
 - d) films can be in any style or on any topic, but must not breach copyright, defamation or anti-discrimination laws;
 - e) more than one film can be entered, but each entry must be accompanied by a completed entry form and the non-refundable entry fee, paid by VISA or Mastercard (with the completed authority attached to this form), Money Order payable to “Home Brewed” or, for Australian entries ONLY, by Cheque payable to “Home Brewed”. The entry fees are as follows:
 - (i) for **Earlybird Entries** entered prior to **1 February 2007 - A\$45 / US\$37**;
 - (ii) for **Standard Entries** entered prior to **30 March 2007 - A\$50 / US\$42**;
 - (iii) for **Late Entries** entered prior to **30 April 2007 - A\$60 / US\$47**.
2. The Producer / Director / Entrant warrant in relation to the film entered, that:
 - a) they are the sole owner of copyright and all other necessary rights in the entry to allow use of that entry by Home Brewed for all of the purposes contemplated in this Entry Form;
 - b) all necessary clearances, licences or authorities from the actors, writers, distributors and owners of any music or sound elements used in the entry, have been obtained if they are required;
 - c) they will on request, provide evidence to the satisfaction of Home Brewed of any of the appropriate clearances and licences referred to above or as otherwise required by Home Brewed;
 - d) they grant (and are fully authorized and able to grant) to Home Brewed all necessary non-exclusive rights for the purposes of the screening of their film as part of the Home Brewed International Film Festival (including reproduction of the film as part of compiling a master screening tape, advertisements or other promotional tools), and for use by Home Brewed in relation to any promotional and/or advertising activity associated with 2007 and subsequent years (the organizers will seek your consent for any use of your film other than for promotional and advertising, ie. further screenings of the film).
3. Entries must be received postmarked prior to **5.00 pm on the relevant closing date**. Home Brewed has absolute discretion to accept late entries.
4. Home Brewed may in its absolute discretion, accept or reject any entry. The outcome of all entries will be advised to the entrant by email ONLY, using the contact details provided in this Entry Form. Films submitted as part of the Home Brewed International Film Festival cannot be returned, unless a stamped and self-addressed envelope is provided for this purpose. Home Brewed accepts no responsibility for loss of or damage to the films in these circumstances.
5. Screening films (at the discretion of Home Brewed) will be selected from all entries that comply with the terms and conditions of entry. Screenings will take place during the festival in October 2007 and will primarily occur in Sydney Australia, although they may also take place at the other festival venues in the Australian cities of Wollongong, Canberra, Melbourne and Bowral. The final program for screenings will be announced in September 2006.
6. In addition to screening opportunities for selected feature films, prizes or additional benefits for independently judged features may be periodically announced subject to sponsor and judge availability, in the lead up to the Festival on <http://www.homebrewedfilm.com>
